IRRIGATION SERVICE

APPLICABILITY

Available for pumping load for crop irrigation, subject to the Cooperative's Rules and Regulations.

TYPE OF SERVICE

Single or three phase, sixty (60) cycles, at available voltages. Where only single-phase service is available, motors of less than ten (10) horsepower may be connected if in the judgment of the Cooperative such service can be rendered without unduly affecting existing service. Not more than one (1) irrigation connection shall be made on any single-phase extension.

RATE

Annual Horse Power Charge:

The minimum annual charge shall be Eighteen Dollars (\$18) per horsepower but in no event shall it be less than Four Hundred Fifty Dollars (\$450) per year or more than Nine Hundred Dollars (\$900) per year. Customers will not receive kilowatt hours for the minimum.

On-Peak Season (Billing period from June - September):

First 125 kWh/HP/yr.	\$0.10000/kWh
Next 125 kWh/HP/yr.	\$0.09000/kWh
Next 250 kWh/HP/yr.	\$0.08500/kWh
Excess kWh	\$0.08000/kWh

Off-Peak Season (Billing period from October - May):

All kWh	\$0.08000/kWh
